

## Villa Vanners Breeding Certificate

This contract entered into this \_\_\_\_\_ day of \_\_\_\_\_, year of \_\_\_\_\_ between **June Villa, Villa Vanners, LLC** hereafter referred to as the stallion owner, and \_\_\_\_\_, hereafter referred to as the buyer.

1. The breeding service fee for **Villa Vanner's Taskin**, Gypsy stallion, shall be \$2,000 (Two thousand dollars and no/100). The \$2,000.00 includes a \$500 non-refundable booking fee upon signature of contract. This entitles mare owner to breed one (1) mare to the stallion for this, the 2010/2011 breeding season by artificial insemination, by chilled shipped semen.
2. Balance of \$1,500 is due at the time of collection. Once the stallion is collected, the mare owner must be available with a credit card number. At this time, veterinary and shipping fees will be charged and paid to the vet. Equitainer must be returned within 10 days of receipt or Equitainer replacement will be charged up to \$300 on your credit card.
3. Stallion will be collected upon days recommended by Villa Vanners veterinarian. Villa Vanner's veterinary service requires a 24-Hour notice.
4. In the event of the death of the stallion, or if he becomes unable to stand as a breeding stallion, as determined by a licensed veterinarian, no refunds will be made.
5. Stallion owner reserves the right to substitute frozen semen in the event that the stallion is showing/competing during the time of the request.
6. Any mare to be bred under this contract must be healthy and in sound breeding condition and free from infection and disease and have a clean uterine culture. In the event the service is refused or the mare does not get in foal, the buyer has return privileges and may substitute another mare for a period of 12 months from the original breeding date. Every stallion at Villa Vanners has a Limited Live Foal Guarantee (LLFG). "Live Foal" meaning a foal that stands and nurses. If the mare gets in foal and then loses the foal, the mare owner shall be permitted to rebreed the mare or substitute another mare for a period of 24 months from the original breeding date.
7. Villa Vanners must be notified of mare's pregnancy status within 90 days of the mare's last breeding date. If this condition is not met, Limited Live Foal Guarantee (LLFG) is null and void.
8. Buyer is bound by the normal rules, regulations, and policies of Villa Vanners and must sign a contract and follow all instructions included in the semen shipment. Mare owner is liable for all legal and collection fees . Foal registration papers will not be signed until owner has paid all outstanding bills generated at Villa Vanners, Feathered Fantasia, LLC.
9. This agreement constitutes the entire agreement of the parties, a
